The Good Shepherd Alliance (GSA) assists **homeless women, children and families** in Loudoun County. GSA guides residents to return to self-sufficiency through an in-depth **six-step process**, and provides **counseling and assistance services** for those in need. GSA has achieved an **85% success rate** at seeing residents through to secure housing.

GSA raises funds to operate its **seven emergency and transitional homes** through grants, personal donations, and thrift store sales. More than 91% of funds raise go directly to homeless operations and services. The expenses to maintain and run seven homes are high, so GSA also has an annual fundraiser.

This Golf Tournament is the annual fundraiser.

The people that come to GSA for help do NOT want to be living on the streets or out of their car. **They want to be back to their normal life.** But it is very expensive to live in Loudoun County, and when they fall upon hard times, a marginal or minimum wage paying job is not enough to support a single mom with children, daycare, car repairs, bills, etc.

Loss of that job can be devastating. So they come to GSA.

Last year, GSA assisted more than **2,000 people** that needed some type of assistance to **keep from becoming homeless**. This is pretty amazing, considering GSA has only a handful of paid counselors and staff. You would never think that **Loudoun County has so many people in need**, but we do.
